Prerequisites to applying

- **A minimum of one Process Workshop** with Mary, Ray, Tara or a certified process workshop facilitator (see Process Workshops). It is recommended that this be within the last 3 years.
- **A five-day introduction to biodynamic / fluid tide craniosacral therapy** or Polarity therapy (see website under 'C/S') is strongly recommended.
- **Neither Ray, Mary nor Tara train anyone who uses nicotine or recreational drugs in any amount for any reason.** Applicants must have a commitment to themselves and the people they work with that they will be nicotine and drug free from the time of application through completion of the Foundation Training and must have the intention to abstain for the rest of their lives.

COSTS AND METHODS OF PAYMENT FOR THE CASTELLINO TRAINING, 2013-2016

Total cost for the training (not including food and lodging): 6,600 euros

Breakdown:

Non refundable deposit:

1,400 euros due before 31st of December

or

1,300 if paid before the 30th of September

The deposit is required to finalize registration, thank you.

Remainder:

5,200 euros

This remainder amount can be paid in the following ways:

- 4 payments of 1,300 euros, paid prior to the March module.
- 8 payments of 650 euros paid prior to or on the first day of each module.

Food and Lodging

Food and lodging is not included in the above amount. It will cost around 50 to 55 euros per day, with possibilities of single or double occupancy to be **paid directly to the facility**. More details will follow on this.

The decision to reduce the modules from 7 to 6 days results in an overall savings of 1000 euros (600 for the training and 400 for food and lodging).
